2016 Born Bull Calves

3. Consigner will be allowed to Buy-Back his bull.
 - a. If consigner chooses to Buy-Back, consigner will be responsible for paying a standard \$1000 Birth Year Payment
4. Bucking Bull Games will only accept consignments from Breeder's with 5 or more bulls.
5. Bulls must be ABBI Registered
 - a. Bulls must be EID Tagged
 - b. Bulls DNA must be confirmed and verified on both Sire and Dam side
6. Bucking Bull Games will pay for all costs associated with Sale Production
7. ALL BULLS MUST BE APPROVED BY BUCKING BULL GAMES
8. DEADLINE – JUNE 30TH 2017 – 5PM CST
